

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN REDWOOD CITY

WHEREAS, the parties entered into an Agreement for IEP meeting interpretations provided by, Bullseye Translation LLC effective on July 01, 2024, for fiscal year 2024-2025, for an amount not to exceed \$25,000.00; and

WHEREAS, the parties now desire to amend the Agreement to provide IEP meeting interpretations for an additional amount not to exceed \$15,000.00; and

1. The first amendment of the agreement is hereby amended to increase the maximum cost of the contract services to \$40,000.00; which includes a maximum obligation of \$15,000.00 for this amendment agreement; and
2. Paragraph 1 of the Agreement is hereby amended to provide IEP meeting interpretations beginning January 09, 2025; and
3. All other terms and conditions of the Agreement dated 7/01/2024 between DISTRICT and Bullseye Translations LLC shall remain in full force and effect.
