

**SECOND AMENDMENT TO THE AGREEMENT BETWEEN REDWOOD CITY

THIS AMENDMENT, entered into this 17th day of April, 2025, by and between the REDWOOD CITY ELEMENTARY SCHOOL DISTRICT (hereinafter called DISTRICT), a political subdivision of the State of California, and Bullseye Translation LLC.

WHEREAS, the parties entered into an Agreement for IEP interpretations provided by, Bullseye Translation LLC effective on July 01, 2024, for fiscal year 2024-2025, for an amount not to exceed \$25,000.00; and


WHEREAS, the parties entered into a First Agreement for IEP interpretations provided by, Bullseye Translation LLC effective on January 9, 2025, for fiscal year 2024-2025, for an additional amount not to exceed \$15,000.00; and

WHEREAS, the parties now desire to amend the Agreement to provide IEP interpretations for an additional amount not to exceed \$15,000.00; and

WHEREFORE, THE PARTIES HEREBY AGREE TO AMEND THE AGREEMENT AS FOLLOWS:

1. The second amendment of the agreement is hereby amended to increase the maximum cost of the contract services to \$55,000.00; which includes a maximum obligation of \$15,000.00 for this amendment agreement; and
2. Paragraph 1 of the Agreement is hereby amended to provide IEP interpretations beginning April 17, 2025; and
3. All other terms and conditions of the Agreement dated 07/01/2024 between DISTRICT and Bullseye Translation LLC shall remain in full force and effect.
