

**THIRD AMENDMENT TO THE AGREEMENT BETWEEN REDWOOD CITY
ELEMENTARY SCHOOL DISTRICT AND BULLSEYE TRANSLATION LLC FOR IEP
MEETING INTERPRETATIONS.**

THIS AMENDMENT, entered into this 4th day of June, 2025, by and between the REDWOOD CITY ELEMENTARY SCHOOL DISTRICT (hereinafter called DISTRICT), a political subdivision of the State of California, and Bullseye Translation LLC.

W I T N E S S E T H

WHEREAS, the parties entered into an Agreement for IEP Interpretations provided by, Bullseye Translation LLC effective on July 01, 2024, for fiscal year 2024-2025, for an amount not to exceed \$25,000.00; and

WHEREAS, the parties entered into a First Agreement for IEP Meeting Interpretations provided by, Bullseye Translation LLC effective on January 9, 2025, for fiscal year 2024-2025, for an additional amount not to exceed \$15,000.00; and

WHEREAS, the parties entered into a Second Agreement for IEP Meeting Interpretations provided by, Bullseye Translation LLC effective on April 17, 2025, for fiscal year 2024-2025, for an additional amount not to exceed \$15,000.00; and

WHEREAS, the parties now desire to amend the Agreement for IEP Meeting Interpretations for an additional amount not to exceed \$9,420.00; and

WHEREFORE, THE PARTIES HEREBY AGREE TO AMEND THE AGREEMENT AS FOLLOWS:

1. The third amendment of the agreement is hereby amended to increase the maximum cost of the contract services to \$64,420.00; which includes a maximum obligation of \$9,420.00 for this amendment agreement; and
2. Paragraph 1 of the Agreement is hereby amended for IEP Meeting Interpretations beginning June 4, 2025; and
3. All other terms and conditions of the Agreement dated 07/01/2024 between DISTRICT and Bullseye Translation LLC shall remain in full force and effect.
