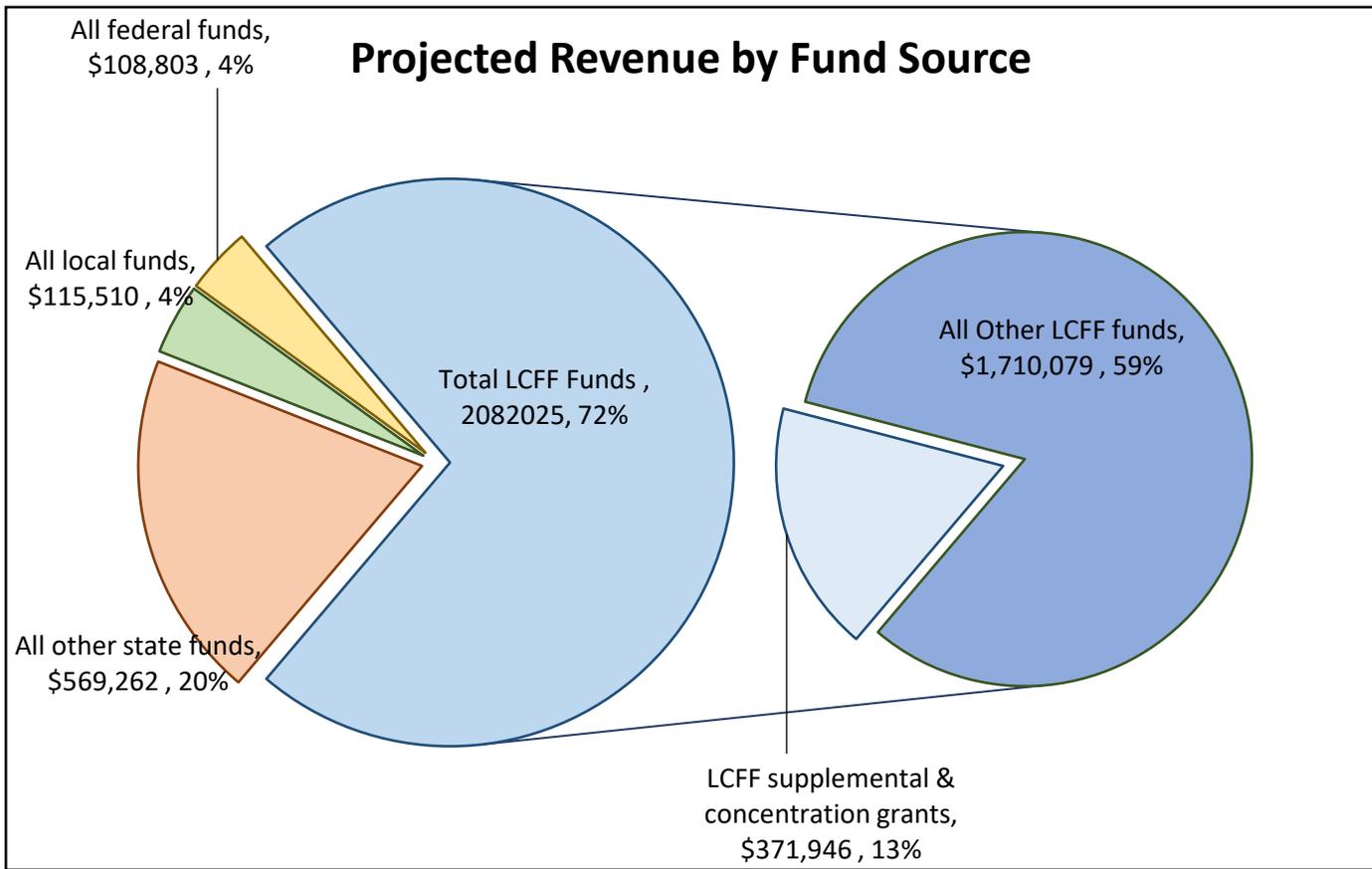

Projected Revenue by Fund Source

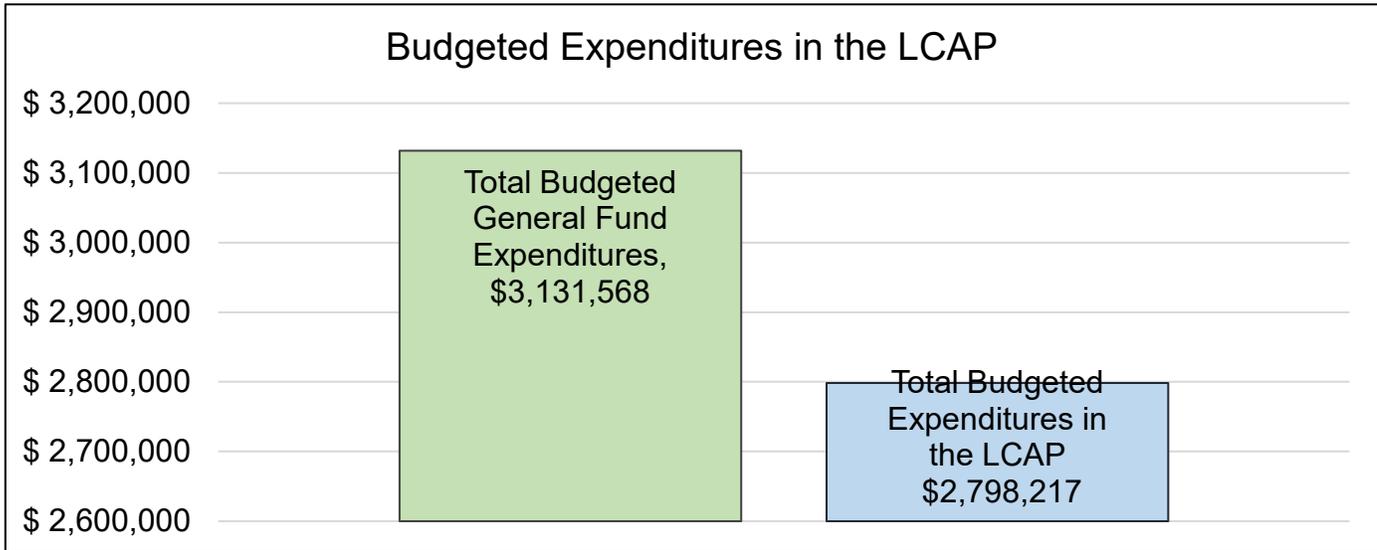


This chart shows the total general purpose revenue Connect Community Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Connect Community Charter School is \$2,875,600.00, of which \$2,082,025.00 is Local Control Funding Formula (LCFF), \$569,262.00 is other state funds, \$115,510.00 is local funds, and \$108,803.00 is federal funds. Of the \$2,082,025.00 in LCFF Funds, \$371,946.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

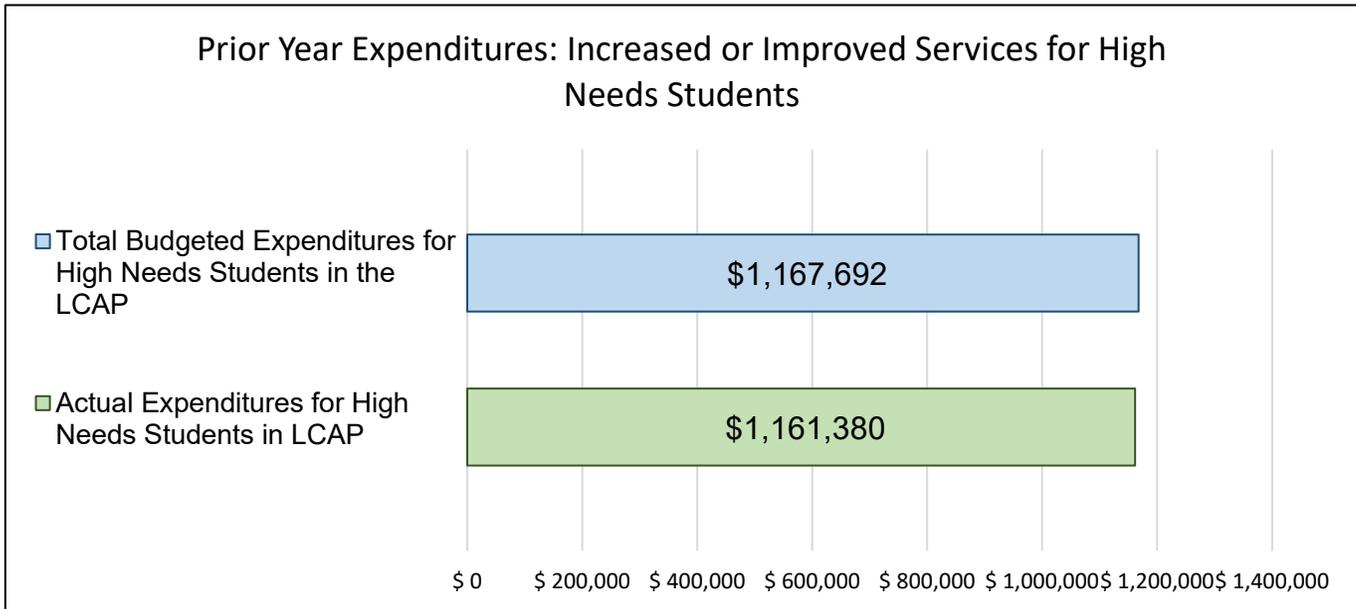

Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

In 2025-26, Connect Community Charter School is projecting it will receive \$371,946.00 based on the enrollment of foster youth, English learner, and low-income students. Connect Community Charter School plans to spend \$592,889.00 towards meeting this requirement, as described in the LCAP.

Update on Increased or Improved Services for High Needs Students in 2024-25

The text description of the above chart is as follows: In 2024-25, Connect Community Charter School's LCAP budgeted \$1,167,692.00 for planned actions to increase or improve services for high needs students. Connect Community Charter School actually spent \$1,161,380.00 for actions to increase or improve services for high needs students in 2024-25. The difference between the budgeted and actual expenditures of \$6,312.00 had the following impact on Connect Community Charter School's ability to increase or improve services for high needs students:

The total actual expenditures for actions and services to increase or improve services for high needs students in 2024-25 was less than 0.54% difference from the total budgeted expenditures. This is an immaterial variance in cost for the actions.

Plan Summary 2025-26

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Connect Community Charter School (“Connect”) is an independent K-8 public charter school in Redwood City. The school opened in the fall of 2013 and shares a site with Fair Oaks Community School. The vision of the school is to prepare and inspire students to create positive change in their communities. The mission is that the school will build a diverse, inclusive, and intellectually stimulating learning environment and emphasize the cognitive and social-emotional skills to inspire intellectually and emotionally intelligent problem-solvers. The school uses an instructional approach that is based on inquiry and project-based learning. There are some metrics which do not apply to Connect because it is a TK-8 Charter School: A-G requirements, CTE Completion, AP Passage Rate, EAP ELA and Math, HS Dropout Rate, and HS Graduation Rate.

The California School Dashboard (“Dashboard”) in 2024 reports that in 2023-24, Connect served 132 students with diverse needs and backgrounds: 85.6% socioeconomically disadvantaged (“SED”) or low income (“LI”) students; 61.4% of students were English Learners (“ELs”); 16% of English Learners were Redesignated Fluent English Proficient (“RFEP”); 17.4% of students with disabilities (“SWD”); 0% Foster Youth (“FY”); and, 10.6% Homeless Youth. As of the 2023-24 school year, enrollment by race and ethnicity at Connect was Hispanic/Latinx (94.7%), White (2.3%), Asian (1.5%), and American Indian (0.8%). It should be noted that the supplemental and concentration grant funds that come from the Local Control Funding Formula (“LCFF”) are for ELs, SED/LI, and FY. Of these subgroups, SED students and ELs are significant subgroups at Connect; however, the Charter School addresses specific actions and services for FY students to provide equal access to a high-quality program. The significant subgroups at Connect based on the 2024 Dashboard are Hispanic/Latinx students, SED students, ELs, and HY.

The purpose of this Local Control Accountability Plan (“LCAP”) is to address the School Plan for Student Achievement (“SPSA”) for Connect Community Charter School which is the Schoolwide Program; herein referred to as the LCAP. The Charter School’s plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The plans included in the LCAP address these requirements compliant to include focusing on three goals: GOAL 1: Student Achievement: All students, including significant subgroups, unduplicated students, and students with exceptional needs, demonstrate growth and measurable progress in English Language Arts (“ELA”) and Mathematics (“Math”) as measured by State and local assessments. GOAL 2: Student Engagement: All students, including significant subgroups, unduplicated students, and students with exceptional needs, will receive social emotional well-being support through

character development and enrichment activities in a safe, inclusive, learning environment which fosters a strong relationship between teachers and students. GOAL 3: Parent and Community Engagement: Connect's parents/guardians, teachers, staff, and community members will be contributing members of the school community through active engagement, communication, collaboration, and decision-making as partners in education to provide students with a well-rounded education.

Connect is not eligible for LCFF Equity Multiplier Funding.

The Charter School completed a comprehensive needs assessment of the entire school which included an analysis of verifiable state data and local performance data used to measure student outcomes as evidenced in the annual update portion of the LCAP. The needs assessment process included meeting parents, classified staff, teachers and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity. The identification of the process for evaluating and monitoring the implementation of the LCAP and the progress toward accomplishing the established goals will include discussing the actions and services with the use of supplemental funds at the school level through the Community Meetings and the District English Learner Advisory Committee ("DELAC"). The DELAC meet a minimum of four times per year to inform the process. Parents, classified staff, certificated staff and an administrator will make up the DELAC. The number of parents will exceed or be equal to the number of total staff members. The DELAC discuss academic performance, supplemental services and areas to make improvements with Title funds as part of the School Plan included in the LCAP conversations at the meeting in the fall and at the meeting in the spring. The teachers, staff, students and parents also participate in an annual survey which provides feedback on the goals and actions. The teachers, staff and administrators actively participate in the decision making process throughout the year and during LCAP workshops. The decisions will take into account the needs of Connect Community Charter School based on student achievement data to include SBAC, ELPAC, and interim assessment data such as IXL and Dibels (starting in 2025-26), cumulative assessments, attendance, and student discipline data to include the significant subgroups of Hispanic/Latinx students, SED students, HY, and ELs and RFEPs. This student achievement data, attendance data, and student discipline data will be used as a basis for making decisions about the use of supplemental federal funds and the development of policies on basic core services.

Each goal includes actions and services that address the needs of all students and significant subgroups which include evidence-based strategies that provide opportunities for all students, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The 2024 California State Dashboard only identifies performance levels using one of five status levels (ranging from Very Low, Low, Medium, High, and Very High) for state measures. Please note that the status levels associated with the Chronic Absenteeism and Suspension Rate Indicators are reversed (ranging from Very High, High, Medium, Low, and Very Low).

-English Language Arts (overall "Low" – 72.2points below standard, increased 15.5 points). The following subgroups were "Very Low": English Learners – 106.5 points below standard, maintained 1.3 points; and Socioeconomically Disadvantaged- 77.9 points below standard, maintained 2.2 points. The following subgroup is "Low": Hispanic/Latinx – 76.1 points below standard, increased 17.2 points. The following subgroups have no Performance Level, both of which improved: Long-Term English Learners – 81.9 points below standard, increased 44.3 points; and Students with Disabilities – 77.1 points below standard, increased 21.9 points. **Connect improved English Language Arts**

performance from “Very Low” to “Low” demonstrating an increase of 15.5 points. Connect has been increasing support in all classrooms, instructional aides provide small group instruction and increasing our data driven instruction through professional development and training. We have also added K-8 calibration into our writing benchmarks by having all teachers design, score, and debrief each writing assessment. Based on the educational partner feedback, the teachers noted that the support with small group instruction is improving academic achievement in the classroom. The parents want the students to make significant academic progress moving toward grade level (Goal 1, Actions 2 and 8). Based on the educational partner feedback, the teachers noted that they need support on using student data to inform instruction, differentiate for students, plan for intervention, develop a culturally responsive classroom, and develop a social emotional routine to benefit the identified students. The parents noted that the teachers need support to complete all that is expected of them (Goal 2, Action 6).

-Math (overall “Low” – 105.7 points below standard, increased 5.6 points). The following subgroups were “Low”: English Learners – 123.7 points below standard, increased 11.2 points; Hispanic/Latinx – 108.4 points below standard, increased 9.5 points; and Socioeconomically Disadvantaged - 106 points below standard, increased 4.8 points. The following subgroups have no Performance Level: Long-Term English Learners – 143.2 points below standard, maintained 1.2 points; and Students with Disabilities – 110.7 points below standard, increased 9.5 points. **Connect improved mathematics performance from “Very Low” to “Low” demonstrating an increase of 5.6 points.** Connect has been increasing support in all classrooms, instructional aides provide small group instruction and increasing our data driven instruction through professional development and training. We have also been examining collaborative problem solving to build mathematical thinking and incorporate literacy into math. Based on the educational partner feedback, the teachers noted that the support with small group instruction is improving academic achievement in the classroom. The parents want the students to make significant academic progress moving toward grade level (Goal 1, Actions 2 and 9). Based on the educational partner feedback, the teachers noted that they need support on using student data to inform instruction, differentiate for students, plan for intervention, and develop a social emotional routine to benefit the identified students. The parents noted that the teachers need support to complete all that is expected of them (Goal 1, Actions 5 and 6).

-Chronic Absenteeism (overall “Medium” – 13.1% chronically absent, declined 20.9%). The following subgroups were “Medium”: Socioeconomically Disadvantaged, 14.9% chronically absent, declined 24.5%; Hispanic/Latinx – 13.7% chronically absent, declined 19.9%; and English Learners, 13% chronically absent, declined 22.6%. The following subgroups had no Performance Color: Students with Disabilities – 24% chronically absent, declined 5.4%); Long Term English Learners – 29.4% chronically absent, increased 0.8%; and Homeless Youth– 20% chronically absent). **Connect significantly improved the chronic absenteeism rate from 34% chronically absent to 13.1%, though the Performance level remained “Medium.”** The school has launched a standard operation procedure for attendance - it is a regular focus of our office staff to verify absences, identify students for “re-engagement”, organize classroom-based Independent Study when appropriate, and to provide additional resources to families as they relate to attendance issues whenever possible and appropriate (providing food, clothes, helping connect families to resources related to social services). We used LCAP funds to provide additional hours to our existing office staff to support attendance efforts. Based on the educational partner feedback, the teachers noted that the attendance initiatives will benefit the identified students. The parents had suggestions on how to improve attendance through consistent communication and training on the importance of attending school (Goal 3, Actions 2 and 3).

-Suspension Rate (overall “Very Low” – 0.6% of students were suspended at least one day, declined 3.7%). Connect is a small school so 0.6% is literally one student. The following subgroups were “Low”: Socioeconomically Disadvantaged, 0.7% of students were suspended at least one day, declined 3.6%; and English Learners, 0.9% of students were suspended at least one day, declined 4.3%. The following subgroup was “Very Low”: Hispanic/Latinx - 0.6% of students were suspended at least one day, declined 3.4%. The following subgroups had no Performance Color: Students with Disabilities, 0% of students were suspended at least one day, declined 5.9%; Homeless Youth, 0% of students were suspended at least one day; and Long-Term English Learners, 5.9% of students were suspended at least one day, declined

3.6%. Connect significantly improved the suspension rate from Medium to Very Low, from 4.3% of students were suspended at least one day to 0.6% of students suspended at least one day. Connect continues to work with students on alternatives to suspension to include counseling, restorative practices, schoolwide SEL program, behavior support in the classroom, professional development on classroom management, and positive behavioral interventions and supports. The students with disabilities have the highest suspension rate of any subgroup at the school and includes only two students. Connect will focus on working with the IEP Team through the IEP to address any Behavioral Plans or Goals that would better support students with disabilities in addition to the support offered to all students previously mentioned. Based on the educational partner feedback, the teachers noted that they need parents to support the academics, climate and culture, and attendance expectations of the school community. The parents want to be involved and want to know how to support the school community and how to support their children at home. We expect that the parent participation rate will increase and that parents will learn to partner with the educators to increase student outcomes through parent education and involvement. The action is designed to meet the needs most associated with the barriers to achievement of the identified students (Goal 3, Actions 1 and 2). The internal data shows that 2023-24 Suspension Rate is only 1.3%.

-English Learner Progress Indicator is “High” 47.8% of English Learners are making progress toward English Language Proficiency which increased 21.3%. **Connect significantly improved the English Learner Progress Indicator from Very Low to High, from 26.5% English Learners are making progress toward English Language Proficiency to 47.8%. This is an increase of 21.3% changing from “Very Low” to “High”.** English Learners have daily ELD instruction from an appropriately credentialed teacher and Specially Designed Academic Instruction in English in their core content areas. Based on the educational partner feedback, the teachers noted that the support with systematic ELD instruction, monitoring, and support is improving language proficiency. The parents want to prevent students from being classified as LTELs by meeting English Proficiency in the primary grades (Goal 1, Action 3).

Connect Met all Local Indicators in 2024: Implementation of Academic Standards, Access to a Broad Course of Study, Basics (Teachers, Instruction Materials, Facilities), Parent and Family Engagement, and Local Climate Survey.

Reflections: Technical Assistance

Connect has been moved from Differentiated Assistance in 2023 to General Assistance in 2024! Connect was in Differentiated Assistance in 2023 for SED students, but in 2024, the SED students met criteria in Priority Areas 4 for ELA and Math performance and in Priority Area 5 for chronic absenteeism rate. SED students increased from “Very Low” to “Low” in ELA demonstrating an increase of 15.5 points. SED students increased from “Very Low” to “Low” in Math demonstrating an increase of 5.6 points. SED students increased from “Very High” to “Medium” demonstrating a 24.5% decline in chronic absenteeism rate. Connect has been exited for Comprehensive Support and Improvement in 2024!

The LCAP was influenced by the feedback provided by the educational partners by continuing with the three goals: Student Achievement, Student Engagement, and Parent/Guardian and Community Engagement. The feedback indicated that the Charter School should continue to implement the actions with fidelity. The educational partners are pleased with the improvement evidenced on the 2024 Dashboard. The feedback was to shorten the actions to ensure clear focus.

An explanation of why the LEA has developed this goal.

Connect has reviewed ELA, Math, Science, and English Learner Proficiency data and is committed to improving student achievement for all students and significant subgroups. 2024 CA Dashboard demonstrated that **Connect improved English Language Arts performance for all students from “Very Low” to “Low” demonstrating an increase of 15.5 points.** 2024 Dashboard is Very Low for English Learners and Socioeconomically Disadvantaged students; Low for Hispanic/Latinx students; and no Performance Level for Long-Term English Learners and Students with Disabilities. 2024 CA Dashboard demonstrated that **Connect improved mathematics performance for all students from “Very Low” to “Low” demonstrating an increase of 5.6 points.** 2024 Dashboard is Low for English Learners, Hispanic/Latinx, and Socioeconomically Disadvantaged students; and no Performance Level for Long-Term English Learners and Students with Disabilities. **Connect improved Science performance by 31% from Grade 5 in 2021 to Grade 8 in 2024.** The 2024 Dashboard demonstrated that **Connect improved the English Learner Progress Indicator from Very Low to High, from 26.5% English Learners are making progress toward English Language Proficiency to 47.8%.**

The following actions had a 10% variance increase or decrease in Budgeted Expenditures and Estimated Actual Expenditures:
Action 1 (Implementation of Core Curriculum): Actual expenditure \$8,685; Budgeted Expenditure \$9,821. This is a decrease of 12% of budgeted expenditure. This action was decreased due to the cost of curriculum training.
Action 6 (Data Informed Instruction): Actual expenditure: \$6,897 Budget Expenditure \$6,183. This is an increase of 12% of budgeted expenditure. This action was increased due to cost of assessment system and teacher collaboration.
Action 7 (Intervention Instructional Materials): Actual expenditure: \$30,284; Budget Expenditure \$43,285. This is a decrease of 30% of budgeted expenditure. This action was decreased because most of the supplemental materials were already purchased.
Action 11 (Support of Students with Disabilities): Actual expenditure: \$339,536; Budget Expenditure \$236,741. This is an increase of 43% of budgeted expenditure. This action was increased due to the cost of services for SWD.

The School Attendance Rate is 94.5% which is an increase from last year which was 94.23%. **Connect has improved significantly in this area from 34% chronically absent to 13.1%, though the Performance level remained “Medium.”** The following subgroups were “Medium”: Socioeconomically Disadvantaged, Hispanic/Latinx, and English Learners. The following subgroups had no Performance Color: Students with Disabilities, Long Term English Learners, and Homeless Youth. Connect is a small school so 0.6% is literally one student. **Connect improved the suspension rate from Medium to Very Low, from 4.3% of students were suspended at least one day to 0.6% of students suspended at least one day.** The following subgroups were “Low”: Socioeconomically Disadvantaged and English Learners. The following subgroup was “Very Low”: Hispanic/Latinx. The following subgroups had no Performance Color: Students with Disabilities, Homeless Youth, and Long-Term English Learners. The 2024 CAST scores for Science in grades 5 and 8 are lower than the State, but students in **Grade 5 in 2021 demonstrated a 31% by Grade 8 in 2024.**

The following actions had a 10% variance increase or decrease in Budgeted Expenditures and Estimated Actual Expenditures:

Action 1 (Field Trips): Actual expenditure \$45,700; Budgeted Expenditure \$23,175. This is an increase of 97% of budgeted expenditure. This action was increased due to the increased number of field trips to include two trips per grades and the grades 4-8 overnight field trip to Yosemite. Connect did raise \$25,000 to fund field trips which supplemented the budgeted amount.

Action 3 (Data Informed Instruction): Actual expenditure: \$15,444; Budget Expenditure \$19,878. This is a decrease of 22% of budgeted expenditure. This action was decreased due to donations of school supplies and appropriate use of supplies.

Action 5 (Enrichment Programs): Actual expenditure: \$60,340; Budget Expenditure \$27,089. This is an increase of 123% of budgeted expenditure. This action was increased because of the costs of materials and staff.

Action 8 (Social Emotional Learning): Actual expenditure: \$4,829; Budget Expenditure \$6,818. This is a decrease of 29% of budgeted expenditure. This action was decreased due to fewer times of character development training.

The following subgroups were “Medium”: Socioeconomically Disadvantaged, 14.9% chronically absent, declined 24.5%; Hispanic/Latinx – 13.7% chronically absent, declined 19.9%; and English Learners, 13% chronically absent, declined 22.6%. The following subgroups had no Performance Color: Students with Disabilities – 24% chronically absent, declined 5.4%); Long Term English Learners – 29.4% chronically absent, increased 0.8%; and Homeless Youth– 20% chronically absent). **Connect significantly improved the chronic absenteeism rate from 34% chronically absent to 13.1%, though the Performance level remained “Medium.”**

-Suspension Rate (overall “Very Low” – 0.6% of students were suspended at least one day, declined 3.7%). Connect is a small school so 0.6% is literally one student. The following subgroups were “Low”: Socioeconomically Disadvantaged, 0.7% of students were suspended at least one day, declined 3.6%; and English Learners, 0.9% of students were suspended at least one day, declined 4.3%. The following subgroup was “Very Low”: Hispanic/Latinx - 0.6% of students were suspended at least one day, declined 3.4%. Connect is committed to improving the attendance rate, reducing the chronic absenteeism rate, and the suspension rate. Moreover, Connect is committed to ensuring students, staff, and parents understand the social emotional well-being of the students through a climate survey which includes questions on school connectedness and safety and through Parent Education Workshops. Connect will provide educational opportunities through field trips and real world experiences. Students will be provided with needed school supplies. Most importantly, Connect will provide a School Counselor and Therapy. With a deep focus on social emotional learning and character development, the students will demonstrate improved behavior. Connect will host Parent Education Workshops which are necessary to achieve a partnership between home and school. Connect believes that with this support and understanding all students and significant subgroups, especially low income students, foster youth, and English Learners will see an increased attendance rate and decreased chronic absenteeism rate and suspension rate.
