EXECUTIVE SUMMARY

The 2025–26 First Interim Financial Report provides an update on the District’s financial condition based on actual revenues and expenditures through October 31, 2025, and revised projections for the remainder of the fiscal year and the subsequent two fiscal years. In accordance with Education Code section 42130, the report demonstrates the District’s ability to meet its financial obligations for the current year and the two-year projection period.

As a Community-Funded (Basic Aid) district, Redwood City School District’s primary revenue source is local property taxes rather than Local Control Funding Formula (LCFF) state aid. For the 2025–26 fiscal year, total General Fund revenues are projected at approximately \$157.8 million, reflecting current local revenue assumptions, including projected property tax growth and transfers. General Fund expenditures are projected at approximately \$160.1 million, resulting in an operating deficit that is supported by available beginning fund balance.

Personnel-related costs, including salaries and benefits, continue to represent the largest share of General Fund expenditures, accounting for approximately 77 percent of total spending. These costs are driven by staffing levels, step and column movement, statutory pension contribution rates, and health and welfare benefits. Non-personnel expenditures primarily consist of services and operating costs necessary to support instructional programs, special education services, and district operations.

The District’s multi-year projections indicate that, while expenditures continue to outpace revenues in certain years, the District projects positive ending fund balances and meets the minimum 3 percent Reserve for Economic Uncertainty requirement in all projection years. The projections incorporate known cost drivers and include unidentified fiscal stabilization measures in the out-years; the specifics of these measures will be identified and incorporated into the Second Interim report.

In addition to the General Fund, the First Interim report includes a summary of other district funds, all of which are projected to remain solvent through the current fiscal year. Bond and capital-related funds continue to support voter-approved facilities projects and long-term infrastructure needs.

While the District’s financial condition remains stable based on current information, ongoing monitoring is required in key areas, including local revenue trends, rising ongoing costs and liabilities, enrollment and program demand, staffing and compensation sustainability, and facilities and operational impacts. Based on the information presented in this report, the staff recommends a Positive Certification, indicating that the District will meet its financial obligations for the current fiscal year and the subsequent two fiscal years.







Part IV - Carry-forward Adjustment

Overview

Education Code Section 42130: Requires that school districts certify to the State the fiscal stability of the District. Districts must demonstrate they can meet their fiscal obligations for the current year and two years out. The reports must be presented to and approved by the District's Governing Board no later than 45 days after the close of the report period.

- ❑ 1st Interim, covers actual expenditures and actual revenues from July 1 through October 31, and updates projections for the balance of the year
- ❑ 2nd Interim, covers actual expenditures and actual revenues from July 1 through January 31, and updates projections for the balance of the year
- ❑ If needed due to Qualified Certification at 2nd Interim, 3rd Interim, covers actual expenditures and actual revenues from July 1 through April 30, and updates projections for the balance of the year

Overview

The Certification of the District's financial condition may take one of three forms:



Positive Certification: The District will meet its financial obligations for the current fiscal year and subsequent two years.

Qualified Certification: The District may not meet its financial obligations for the current fiscal year or subsequent two years.

Negative Declaration: The District will not meet its financial obligations for the remainder of the fiscal year or for the subsequent fiscal years.




