

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN REDWOOD CITY  
ELEMENTARY SCHOOL DISTRICT AND NICOLE CAMPBELL FOR A  
SPEECH AND LANGUAGE PATHOLOGIST.**

THIS AMENDMENT, entered into this 29th day of December, 2025, by and between the REDWOOD CITY ELEMENTARY SCHOOL DISTRICT (hereinafter called DISTRICT), a political subdivision of the State of California, and Nicole Linette Campbell.

W I T N E S S E T H

WHEREAS, the parties entered into an Agreement to provide a Speech and Language Pathologist provided by, Nicole Linette Campbell effective on November 04, 2025, for fiscal year 2025-2026, for an amount not to exceed \$47,232.00; and

WHEREAS, the parties now desire to amend the Agreement to extend the end term date to March 1, 2026, for an additional amount not to exceed \$19,680.00; and

WHEREFORE, THE PARTIES HEREBY AGREE TO AMEND THE AGREEMENT AS FOLLOWS:

1. The first amendment of the agreement is hereby amended to increase the maximum cost of the contract services to \$66,912.00; which includes a maximum obligation of \$19,680.00 for this amendment agreement; and
2. Paragraph 1 of the Agreement is hereby amended to extend the end term date to March 1, 2026 starting February 1, 2026; and
3. All other terms and conditions of the Agreement dated 11/04/2025 between DISTRICT and Nicole Linette Campbell shall remain in full force and effect.
