**Resolution of the Board of Trustees of the Redwood City School District
Regarding Non-Reemployment of Certificated Employees**

WHEREAS, on February 11, 2026, the Governing Board of the Redwood City School District ("District") adopted Resolution No. 17: 2025-2026 to decrease certificated staff due to a reduction or elimination in particular kinds of services; and

WHEREAS, notice of non-reemployment was given to the affected employees on or before March 15, 2026; and

WHEREAS, all of the affected employees waived their right to a hearing; and

WHEREAS, it has been determined that 18.26 full-time equivalent certificated services of the District be reduced or eliminated and certain certificated staff be non-reemployed for the ensuing 2026-2027 school year as a result.
