

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN REDWOOD CITY

WHEREAS, the parties entered into an Agreement for IEP meetings interpretations provided by, Bullseye Translations, LLC effective on August 15, 2025, for fiscal year 2025-2026, for an amount not to exceed \$30,000.00; and

WHEREAS, the parties now desire to amend the Agreement to provide IEP meetings interpretations for an additional amount not to exceed \$29,000.00; and

WHEREFORE, THE PARTIES HEREBY AGREE TO AMEND THE AGREEMENT AS FOLLOWS:


1. The first amendment of the agreement is hereby amended to increase the maximum cost of the contract services to \$59,000.00; which includes a maximum obligation of \$29,000.00 for this amendment agreement; and
2. Paragraph 1 of the Agreement is hereby amended to provide IEP Meetings interpretations beginning April 22, 2026; and
3. All other terms and conditions of the Agreement dated 08/15/2025 between DISTRICT and Bullseye Translation, LLC shall remain in full force and effect.


