

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN  
REDWOOD CITY SCHOOL DISTRICT AND BOYS & GIRLS CLUBS OF THE PENINSULA  
FOR EXPANDED LEARNING PROGRAMMING**

THIS AMENDMENT, entered into this 5<sup>th</sup> day of June, 2026, by and between the REDWOOD CITY ELEMENTARY SCHOOL DISTRICT (hereinafter called DISTRICT), a political subdivision of the State of California, and Boys & Girls Clubs of the Peninsula.

W I T N E S S E T H

WHEREAS, the parties entered into an Agreement for expanded learning programming effective on June 25, 2025, for Summer 2025 and the 25/26 School Year, for an amount not to exceed \$2,000,000.00; and

WHEREAS, the parties now desire to amend the contracted amount to reflect and align with the new funding received through the After School Education and Safety grant program for an additional amount not to exceed \$406.96; and

WHEREFORE, THE PARTIES HEREBY AGREE TO AMEND THE AGREEMENT AS FOLLOWS:

1. Paragraph 5 of the Agreement is hereby amended to increase the maximum cost of contract services to \$2,000,406.96, which includes a maximum obligation of \$406.96 for this amendment agreement.
