**Resolution of the Board of Trustees of the Redwood City School District  
Education Code & Title 5 Options for Teaching Assignment(s) for 2026-2027 School Year**

**WHEREAS**, this Board is the Governing Body of the Redwood City School District; and

**WHEREAS**, EC 44256(b) expands the authorization for the holder of a Multiple Subject or a Standard Elementary Teaching Credential to teach in a departmentalized setting in grades 9 and below; and

**WHEREAS**, EC 44258.2 allows the holder of Single Subject or Standard Secondary Teaching Credential to be assigned to teach classes in grades 5 through 8, inclusive, in a middle school in the subject to which the credential holder is assigned; and

**WHEREAS**, EC 44831 allows the holder of a license issued by the Speech-Language Pathology and Audiology Board and has earned a masters degree in communication disorders to provide speech and language services; and

**WHEREAS**, Cal. Code Regs. Tit. 5, § 80005(b) - Authorization for Subject Areas for Service in Departmentalized Classes, expands the authorization for the holder of a Teaching Credential to teach subject-matter classes which do not fall within or are not directly related to the broad subject areas listed on their document; and

**WHEREAS**, Cal. Code Regs. Tit. 5, § 80020.4 - Staff Development, allows the holder of a California teaching credential based on a baccalaureate degree and a teacher preparation program, including student teaching or the equivalent, to serve as school-site, school district, and or county staff developer in grades twelve and below, including preschool, and in classes organized primarily for adults; and

**WHEREAS**, the Deputy Superintendent has determined the teacher(s) have the requisite knowledge and skills for teaching assignments to ensure that all students are prepared to be successful in high school and beyond; and

**WHEREAS**, pursuant to the Local Plan and the Education Code, changes such as the one proposed require the approval of this Board; and

**WHEREAS**, this Board has considered the Deputy Superintendents' recommendations and other matters pertaining to this action and desires to approve the change to teaching assignments;

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the proposed Education Code option(s) and Title 5 options(s) for teaching assignment(s) attached hereto as and incorporated herein by reference is approved.

**IT IS FURTHER DETERMINED AND ORDERED** that the Superintendent shall cause to be distributed a copy of this resolution to be transmitted to the San Mateo County Sr. Credential Analyst.
