

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN
REDWOOD CITY SCHOOL DISTRICT AND ONE LIFE COUNSELING
FOR COUNSELING SERVICES**

THIS AMENDMENT, entered into this 2nd day of September, 2026, by and between the REDWOOD CITY SCHOOL DISTRICT (hereinafter called DISTRICT), a political subdivision of the State of California, and One Life Counseling (hereinafter called VENDOR),

WHEREAS, the parties entered into an Agreement for Counseling effective on August 10, 2026 through June 30, 2027, for an amount not to exceed \$876,750; and

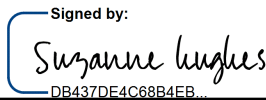
WHEREAS, the parties now desire to amend the Agreement to increase counseling at MIT for an additional 10 hours per week for an additional amount not to exceed \$24,500 and

WHEREFORE, THE PARTIES HEREBY AGREE TO AMEND THE AGREEMENT AS FOLLOWS:

1. This first amendment of the Agreement is hereby amended to increase the maximum cost of contract services to \$901,250; which includes the maximum obligation of \$24,500 for this amendment agreement: and
2. Paragraph 1 of the Agreement is hereby amended to provide additional counseling services at MIT; and
3. All other terms and conditions of the Agreement dated August 10, 2026 between DISTRICT and ONE LIFE shall remain in full force and effect.
